- Carry out the collection of recyclable materials from IMPACT and Visy National customers and the supervision of an offsider employee.

 - o forklift start up inspection including, but not limited to, tyre pressure, fluid levels, safety equipment, gauges and controls
 - pre-trip inspection of the truck including, but not limited to, checking tyre pressure, fluid levels, safety equipment, gauges and controls
- Record all incoming/outgoing product quantities/weights in line with policies and procedures
- Accurately complete on a daily basis:
 - product sheets
 - forklift maintenance records
- Carry out loading and unloading as directed and ensure all stock is processed in a timely manner
- Report any production contamination
- Provide assistance to the Recycling & Collections Manager and Supervisors as required
- Effectively communicate with all stakeholders to create and maintain good relationships
- Perform physical tasks within the plant as required
- Demonstrate empathy to people with a disability
- Maintain confidentiality and security of information
- Effectively communicate with all stakeholders to create and maintain good relationships

- Provide cover during staff absences at the Recycling Facility
