The Bundaberg Family Law Pathways Network (BFLPN) is an initiative of the Australian Government Attorney General's Department. The overarching aim of a Family Law Pathways Network (FLPN) is to improve collaboration and coordination between organisations operating in the family law system in order to help separating and separated families obtain appropriate services. By ensuring collaborative referrals and enhancing the understanding of available family services, the Family Law Pathways Networks represent an essential component of the Government's commitment to an accessible justice system that meets the needs of Australian Families.

The Bundaberg Family Law Pathways Network, auspiced by Uniting Care, commenced in July 2010 and services the Wide Bay Burnett region. Membership is broad and inclusive and consists of a diversity of professionals working within the Family Law System across the region.

The Family Law Legal Services Directory has been developed to provide information on legal services crucial to the Family Law System in the Wide Bay Burnett region. Both private and Not for Profit services have been included. Information has been gathered and collated from BFLPN members.
